fight in the back parking lot. Sgt. Gerior and Ofc. Driscoll were dispatched as well. While in route to the school Officer Milligan notified dispatch he was on scene and the gathering had since dispersed on its own prior to his arrival. Once on scene I was able to identify one of the individuals involved, [REDACTED]. [REDACTED] stated he was a member of the Cathedral Highschool football team and was in the parking lot getting ready to leave when a group of unknown individuals began blocking the parking lot in front of his vehicle. At this time [REDACTED] exited the vehicle and asked them to move before a couple unknown males began yelling at him and attempting to entice him to fight them. At this point other members of the Cathedral fans saw the commotion and made their way in his direction before a large group began fighting. By the time police arrived on scene all others involved had left the scene with no known vehicles or descriptions. [REDACTED] was evaluated by medical training staff as well as AFD but refused further medical treatment. [REDACTED]'s mother, [REDACTED] was also present during the altercation. As of this time there are no suspects and no witnesses who could identify the parties involved. Ofc. Milligan will be attempting to view security footage from the school in hopes identifying potential parties involved. Any further information will be documented accordingly.
